The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be EXECUTIVE CARDSERVICE, INC. and its mailing address is 18880 NW 84 Avenue, Miami, Florida 33015.

**ARTICLE II**

This corporation shall have perpetual existence.

**ARTICLE III**

This corporation is organized for the purpose of transacting any and all lawful business for which a Corporation may be incorporated in the State of Florida.
