ARTICLES OF INCORPORATION

OF

FLORIDA BUILDING & INVESTMENTS, INC.

ARTICLE I. - NAME

The name of the corporation is FLORIDA BUILDING & INVESTMENTS, INC., whose address is 608 S. Tyndall Parkway, Panama City, Florida 32401.

ARTICLE II. - PURPOSES

The corporation is being formed for the purpose of engaging in any lawful activity for which corporations may be organize.

ARTICLE III. - DURATION

The duration of the corporation shall exist perpetually commencing on the date of filing.

ARTICLE IV. - CAPITAL STOCK

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.

ARTICLE XI. - RESTRICTIONS ON TRANSFER OF STOCK
