The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adoptothe following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is CLOVER TRADING INC.

ARTICLE TWO

CORPORATE DURATION

The duration of the corporation is perpetual

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:
