# **ARTICLES OF INCORPORATION**

## <u>OF</u>

#### EXVENCO, INC.

We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby from a corporation under the Laws of the State of Florida.

#### **ARTICLE I**

## **NAME OF CORPORATION**

The name of the Corporation shall be EXVENCO, INC.

#### **ARTICLE II**

The general nature of the business to be transacted by this corporation is to act as a purchasing agent to export construction material to Venezuela, and any other activities or business permitted under the laws of the United States and the State of Florida.
