The undersigned Incorporator, a natural person competent to contract, who is a duly licensed Certified Professional Accountant in the State of Florida, hereby subscribes to and adopts these Articles of Incorporation for the purpose of organizing a professional service corporation under the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes Chapter 621, and the Florida Business Corporation Act, Florida Statutes Chapter 607.

ARTICLE I  
CORPORATE NAME

The name of this Corporation shall be:

SCOTT JAMES MARTIN, CPA, P.A.

ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of this Corporation is: 5400 Tangerine Avenue, Winter Park, Florida 32792.

ARTICLE III  
PURPOSES

In accordance with Florida Statutes Section 621.08, this Professional Service Corporation is organized for the following purposes:

(a) To engage in the practice of accounting as a professional corporation and to carry on services incident to the practice of accounting;

(b) To own real and personal property, enter into leases and other contracts and open, maintain and close accounts, all as necessary for the rendering of the aforesaid professional services;

(c) To invest its funds in real estate, mortgages, stocks, bonds or any other types of investments;

(d) To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these Articles of Incorporation, and to do every other act incidental to the corporate purposes which is not forbidden by Florida law or by the provisions of these Articles of Incorporation.

**ARTICLE IV**  
**CAPITAL STOCK**

The maximum number of shares of stock that this Professional Service Corporation is authorized to issue and have outstanding at any one time shall be five thousand (5,000) shares of common stock having a par value of ten (\$0.10) cents per share.

None of the shares of this Professional Service Corporation may be issued to anyone other than: (a) an individual who is duly licensed to engage in the profession of accounting in the State of Florida or (b) a professional service corporation or a professional limited liability company which is wholly owned by one or more individuals who are duly licensed to engage in the profession of accounting in the State of Florida.

**ARTICLE V**  
**TERM OF EXISTENCE**

This Professional Service Corporation shall have perpetual existence.

**ARTICLE VI**  
**INITIAL REGISTERED OFFICE AND AGENT**

The address of the initial Registered Office of this Professional Service Corporation is 5400 Tangerine Avenue, Winter Park, Florida 32792. The name of the initial Registered Agent of this Professional Service Corporation at that address is Scott James Martin.

**ARTICLE VII**  
**BOARD OF DIRECTORS**

The business of this Professional Service Corporation shall be managed by its Board of Directors. The initial Board of Directors shall consist of one (1) member. The name and address of the member of the first Board of Directors is:

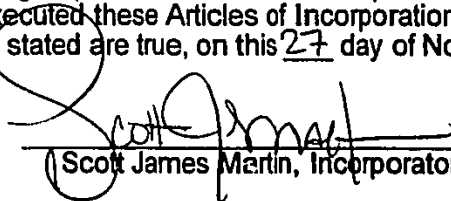

**RESTRAINT ON ALIENATION OF SHARES**

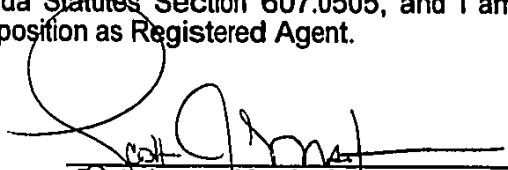
