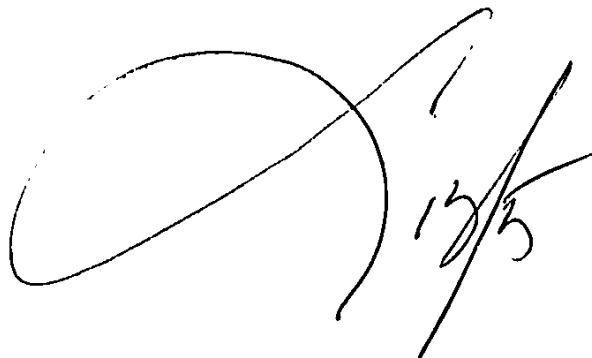

**ARTICLES OF INCORPORATION
OF

FIRST: The name of this corporation is:

HEIDI GARDNER SUPPORT COORDINATION SERVICES, INC.

SECOND: The purpose for which this corporation is formed is to transact any lawful business which may be conducted by corporations pursuant to the laws of the State of Florida.
