ARTICLE L NAME

THE NAME OF THIS CORPORATION SHALL BE:

SGH OF CAPE CORAL, INC.

ARTICLE II. COMMENCEMENT & DURATION

THE COMMENCEMENT OF THIS CORPORATION'S EXISTENCE SHALL BE AT THE TIME OF THE FILING OF
THESE ARTICLES OF INCORPORATION BY THE FLORIDA DEPARTMENT OF INCORPORATION. THIS
CORPORATION'S DURATION SHALL BE PERPETUAL.

ARTICLE IIL PURPOSE
