THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General

Corporation Act, hereby adopt(s) the following Articles of Incorporation:

## ARTICLE I

## NAME

The name of this corporation is FURLOW CONSULTING CORP. The principal place of business is 362 Gulf Breeze Parkway, Suite 202, Gulf Breeze, Florida 32561.

## **ARTICLE II**

## **DURATION**

The duration of this corporation is perpetual.

#### **ARTICLE III**

#### PURPOSE

The general purposes for which this corporation is organized are:

(1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act.
