ARTICLES OF INCORPORATION

OF

SIEWRUK DEVELOPMENT CORPORATION

THE UNDERSIGNED, acting as sole incorporator of **SIEWRUK DEVELOPMENT CORPORATION** (hereinafter the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:

ARTICLE I

Name

Business and Activities
