ARTICLES OF INCORPORATION

OF

A NEW YOU WEIGHT LOSS CENTER, INC.

ARTICLE I - NAME:

The name of this corporation is: A NEW YOU WEIGHT LOSS CENTER, INC., hereinafter referred to as the ("Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Weight Loss Counseling business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

ARTICLE_IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE_RIGHTS:
