The name of this corporation is: RJT PROPERTIES, INC

Article II - Duration

This corporation shall have perpetual existence.

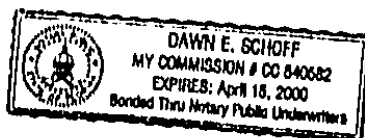
