# ARTICLES OF INCORPORATION OF WILES COMMERCE PARK, INC.



#### ARTICLE I

The name of this corporation shall be:

WILES COMMERCE PARK, INC.

#### ARTICLE II

This corporation shall commence its existence upon the filing of these Articles and the duration of this corporation is perpetual.
