The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be ARMENIA LANDSCAPING AND ENVIRONMENTAL SERVICES, INC.

ARTICLE II. PURPOSE

The corporation shall engage in the business of providing services for profit of lawn and garden design, care, maintenance, and removal with emphasis on the impact on the environment. In addition, the corporation shall undertake any or all other lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 5,000 shares of common stock having no par value.
