ARTICLES OF INCORPORATION

ARMENIA LANDSCAPING AND ENVIRONMENTAL SERVICES, INC.

The undersigned subscriber to these Articles of Angle Of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be ARMENIA LANDSCAPING AND ENVIRONMENTAL SERVICES, INC.

ARTICLE II. PURPOSE

The corporation shall engage in the business of providing services for profit of lawn and garden design, care, maintenance, and removal with emphasis on the impact on the environment.
