**ARTICLES OF INCORPORATION**  
**OF**  
**ACCU-TITLE CORPORATION**

WE, THE UNDERSIGNED, natural persons of the age of eighteen (18) years or more, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation

**ARTICLE I**  
**NAME**

The name of the corporation shall be:

ACCU-TITLE Corporation.

**ARTICLE II**  
**DURATION OF CORPORATION**

The corporation is to have perpetual existence.

**ARTICLE III**  
**GENERAL PURPOSES**

- A. To aquire or merge into existing business.
- B. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise operate real and personal property of all kinds and interests therein.
- C. The enumeration of specific purposes and powers shall not be held to limit or restrict in any manner the purposes and powers of this corporation, and the purposes and powers therein specified shall not be limited or restricted by the terms of this Article or any article hereof.

**ARTICLE IV**  
**CAPITAL STOCK**

The aggregate number of shares which this corporation shall have authority to issue is 10,000 shares, at one dollar (\$1.00) par value. All stock of the corporation shall be of the same class, and shall have the same rights and preferences. Fully paid stock of this corporation shall not be liable to any call or assessment.

**ARTICLE V**  
**PREEMPTIVE RIGHTS AND NONCUMULATIVE VOTING**

Shareholders shall have preemptive rights to acquire unissued shares of the stock of this corporation.

At each election of Directors, shareholders entitled to vote at such election shall have no right to accumulate their votes; rather, each shareholder shall have as many votes as the number of such shareholder's shares.

**ARTICLE VI**  
**COMMENCING BUSINESS**

This corporation will not commence business until at least \$100.00 in cash or property has been received by it as consideration of the issuance of its shares.

**ARTICLE VII**  
**REGISTERED OFFICE, PRINCIPAL, AND AGENT**
