In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

I.

The name of the corporation ("Corporation") is:

"Irie Blue, Inc."

The Corporation is organized for profit and to engage in any business allowed by law.

II.

The street address of the principal office of the Corporation is 3756 Skyline Street, Deltona, Florida 32736.

III.

The maximum number of shares the Corporation is authorized to issue is 1,000, all of which shall be common shares. All common shares shall be identical with each other in every respect, and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

IV.

The preemptive right of any shareholder to acquire authorized and unissued shares of the Corporation is granted.

**V.**

The Corporation shall have authority to issue its shares pursuant to a plan or plans which it may adopt in accordance with Section 1244 of the United States Internal Revenue Code.

**VI.**

The initial street address of the Corporation's registered office is 3756 Skyline Street, Deltona, Florida 32736. The initial registered agent for the Corporation at that address is Richard L. Van Ord.

**VII.**

The initial board of directors shall consist of one member. The name and address of the person who will serve on the initial board of directors is Richard L. Van Ord, 3756 Skyline Street, Deltona, Florida 32736.

**VIII.**

**IX.**

The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.

**X.**

No director of the Corporation shall be personally liable to the Corporation or to its shareholders for damages for breach of a duty of care or other duty as a director, except

to the extent such liability cannot be eliminated or waived under the provisions of F.S. 607.0831.
