The undersigned incorporator, desiring to form a professional corporation in accordance with the applicable provisions of Florida law, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation shall be:

ARTICLE TWO

PURPOSES

The purposes for which the Corporation is organized are as follows:

- (1) To engage primarily in the specific business of sprinkler installation and repair, and lawn care and maintenance;

- (3) To engage in such other business as may be authorized or permitted under Florida law.

**DURATION**


The duration of the Corporation shall be perpetual.

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with applicable law.

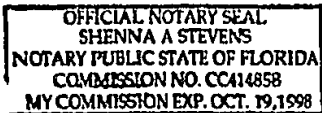
