ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this Corporation is MAC WORLDWIDE, INC. The principal place of business of the corporation shall be 9400 South Dadeland Boulevard, Suite 100, Miami, Florida 33156.

ARTICLE II
