THE undersigned, acting as incorporator of a corporation E. FLORIDA under the Florida General Service Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE 1. NAME: The name of the corporation is: GOLD & SILVER SHOP, INC. Principal office: 135 E. INTERNATIONAL SPEEDWAY DAYTONA BEACH, FL 32118

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.
