**ARTICLES OF INCORPORATION  
OF  
CHARLES F. DUDLEY, P.A.**

The undersigned subscriber to these Article of Incorporation, being duly licensed to practice law under the laws of the state of Florida, adopts these Articles to form a professional corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I. NAME**

The name of the professional corporation is **Charles F. Dudley, P.A.**

**ARTICLE II. PRINCIPAL OFFICE**

**ARTICLE III. PURPOSE**

This professional corporation is formed to engage in the practice of law and to render such services as are ancillary to the practice of law, all in accordance with the rules regulating The Florida Bar and the laws of the State of Florida; to generally engage in and carry on any business incidental thereto; to do any and all other things and to exercise any and all other powers which a Florida professional corporation may by authority or law do or exercise; to construct, lease, purchase or otherwise acquire real and personal property of any nature or interest therein, without limit as to amount or value, reasonably necessary or convenient for effecting or furthering any and all of the purposes and powers of this professional corporation which may now or hereafter be lawful under and in pursuance of the laws of the State of Florida; and to invest this professional corporation's funds in real estate, mortgages, stocks, bonds or any other securities or investments as may be permitted by law.

**ARTICLE IV. TERM OF EXISTENCE**

This professional corporation shall have perpetual existence, starting on the date these Articles of Incorporation are filed with the Florida Department of State.

#### **ARTICLE V. CAPITAL STOCK**

The capital stock of this professional corporation shall be 100 shares of common stock, of a single class and without par value.

None of the shares of this professional corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.

#### **ARTICLE VI. REGISTERED OFFICE AND AGENT**

The address of the initial registered office of this professional corporation is 215 S. Monroe St., Suite 420-A, Tallahassee, FL. 32301. The name of the initial registered agent at that address is Charles F. Dudley.

#### **ARTICLE VII. BOARD OF DIRECTORS**

The business of this professional corporation shall be managed by its Board of Directors. The initial Board of Directors shall consist of one member. The name and address of the initial member of the first Board of Directors is Charles F. Dudley, P.O. Box 10685, Tallahassee, FL 32302.

#### **ARTICLE VIII. SUBSCRIBER**

The name and address of the person signing these Articles of Incorporation as subscriber is Charles F. Dudley, P.O. Box 10685, Tallahassee, FL. 32302.

#### **ARTICLE IX. RESTRAINT ON ALIENATION OF SHARES**

The shareholders of this professional corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the professional corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the shareholders of this professional corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder of this professional corporation may sell or transfer stock in the professional corporation except to another individual who is eligible to be a

shareholder of the professional corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose.


#### ARTICLE X. DISQUALIFICATION

If any shareholder of this professional corporation becomes legally disqualified to practice law in the State of Florida, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, such shareholder's shares of stock shall immediately become subject to purchase by this professional corporation in accordance with the bylaws adopted by the shareholders.

#### ARTICLE XI. AMENDMENT

This professional corporation reserves the right to amend or repeal any provisions in these Articles of Incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.


**CERTIFICATE OF DESIGNATION AND


