Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida for profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Articles 1 and 3 of the Articles of Incorporation are amended to read as follows:


Article 1 of the Articles of Incorporation is amended to change the name of the corporation to:
INSIGHT Counselors, P.A.

Article 3: Purpose: The Professional Association may engage in the business of psychotherapy, marital and family counseling, mediation, parent coordination, and other services permitted to be performed by a Licensed Mental Health Counselor, Clinical Social Worker, Marriage and Family Counselor or Psychologist in the State of Florida.
