ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and form a corporation under the laws of the State of Florida, and does certify that he has become a corporation under and pursuant to the following Articles of Incorporation.

I

The name of this corporation is INFO-QUE, INC.

II

The general nature of the business to be transacted by this corporation is:

1. To do any and all things necessary and pertinent to operate a business having to do with purchasing, trading, leasing, renting, selling, exporting and importing computer products/equipment, advertising, database services, electronic products/equipment and furniture.
2. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, or otherwise dispose of real and personal property and services of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph or telephone or cemetery company, a building and loan association, cooperative association, fraternal benefit society or state fair.
3. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.
4. To purchase the corporate assets of any other corporation and engage in the same or other character of business.
5. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while the owner of such stock to exercise all rights, power and privileges of ownership, including the right to vote such stock.

III

The corporation shall have all the powers given to it by the laws of the State of Florida, now or hereafter, and specific powers herein enumerated shall not be construed as a limitation upon the powers of the corporation.

IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock with a nominal or par value of One (1) Dollar.

V

The amount of capital with which this corporation will begin is a minimum of:

This corporation is to exist perpetually.

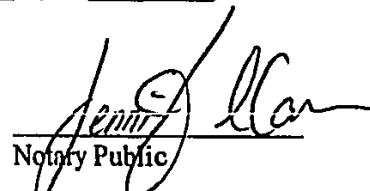
