ARTICLES OF INCORPORATION FOR 200 BISCAYNE CORPORATION

The undersigned, for the purposes of forming a corporation under the Fibridal Govern FLORIDA Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is 200 Biscayne Corporation.
