ARTICLE I - NAME

The name of this corporation is CRUMM, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes: to carry freight for hire; to transport sand, soil and other materials to various destinations throughout the State of Florida and to buy, sell and otherwise deal in trucks, tractors and trailers suitable for commercial trucking, and for the purpose of transacting any or all other lawful business.

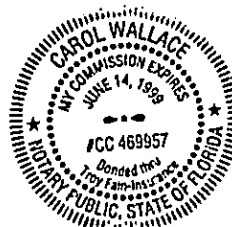
