ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The name and address of the person signing these Articles of Incorporation is NORMA J. ROSE.


ARTICLE X. INDEMNIFICATION

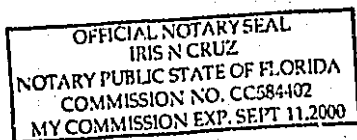




