**ARTICLE I  
NAME**

The name of this corporation shall be:

DAVID H. REIMER, P.A.

**ARTICLE II  
DURATION**

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation.

**ARTICLE III  
PURPOSE**

This corporation is organized for the sole and specific purpose of rendering professional legal services; nevertheless, it shall be authorized to transact any or all lawful business as provided by Florida Statutes, Chapter 621, Professional Service Corporation Act, as it exists on the date here or as it may hereafter be amended.

**ARTICLE IV

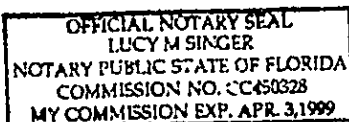
