We the undersigned, hereby make, subscribe, acknowledge and file this Certificate for the purpose of becoming a Corporation under of provisions of Chapter 607 of the State of Florida.

ARTICLE I

The Name of this Corporation shall be:

The general nature of the business to be transacted by this Corporation shall be as follows:

The authorized capital stock of the Corporation shall consist of five hundred (500) shares at no par value.

The whole or any part of the capital stock of this corporation shall be payable in lawful money of The United States of America, or property, labor or services at a just valuation to be fixed by the directors.
