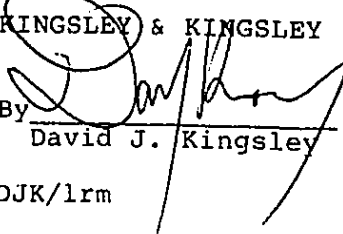

ARTICLE I

NAME

The name of this corporation is Speech-Language Specialists, Inc.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of rendering professional speech-language pathology services and the transacting of any and all other lawful business.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of common stock.

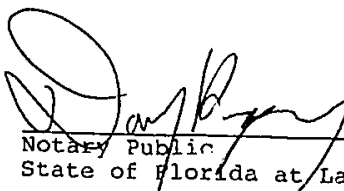

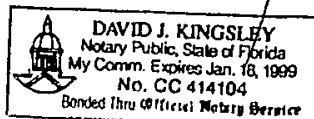
