The undersigned, Paul E. Palmieri, desires to become a body corporate and, as Incorporator, hereby makes and files these Articles of Incorporation for a proposed corporation pursuant to the laws of Florida, and to that end declares and agrees:

ARTICLE I. NAME. The name of this corporation shall be: PEP CONSTRUCTION COMPANY

ARTICLE II. ADDRESS.

Section 1. Principal Office. The street address of this corporation's principal office is 3711 Cortez Road West, Suite 300, Bradenton, Florida 34210. The address of the principal office may be changed from time to time by the Board of Directors as authorized by law.

Section 2. Registered Office. The street address of this corporation's registered office is 3711 Cortez Road West, Suite 300, Bradenton, Florida 34210. The name of this corporation's registered agent at such address is Paul E. Palmieri. The registered office and registered agent may be changed from time to time by the Board of Directors as authorized by law.

ARTICLE II. NATURE OF BUSINESS. This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share.
