The undersigned subscriber of these Articles of Incorporation, a mature person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1

The name of the corporation shall be EDWAY PUBLICATIONS, INC.

This corporation shall exist perpetually.

ARTICLE 3

This corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.
