ARTICLES OF INCORPORATION

OF

SAVANNAH STAR, INC.

The undersigned, being natural persons of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

Article I - Name

The name of the corporation shall be SAVANNAH STAR, INC.

Article II - General

The general nature of business to be transacted by this corporation is to engage in the services of a bar with sales in beer and wine and to engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

Article III - Capitol Stock

A. Authorized Shares

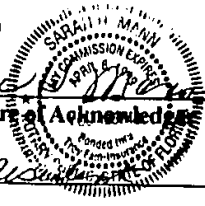
