The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, and an Attorney duly licensed to render a service as such, under the laws of the State of Florida, hereby presents his Articles of Incorporation for the formation of a corporation pursuant to Chapter 621 F.S., and other Laws of the State of Florida.

ARTICLE I. NAME. The name of the corporation shall be MARK V. MORSCH, P.A.
