Regarding the enclosed reinstatement application for The Loan Pros, Inc., since the 1997 incorporation date the corporation has changed office locations three times. The owner has indicated that to the best of his knowledge, he has never received any Annual Reports for the corporation.

The taxpayer has indicated to me that there was some difficulty in having the mail sent from location to another due to administrative problems resulting from employee turnover. The taxpayer has filed all federal and state tax returns on time and adhered to all other reporting requirements.
