The undersigned subscriber to these Articles of Incorporation,
natural persons competent to contract, hereby subscribe to and
form a corporation for profit under the laws of the State of Florida.

ARTICLE I

(Name)

1.01 The name of the corporation is J.P.T.G., Inc.

ARTICLE II

(Nature of Business)

2.01 The corporation may engage in any activity or business that is permitted under the laws of The United States of America and of this State.
