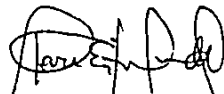

## **ARTICLES OF INCORPORATION**

THE UNDERSIGNED, as proper persons acting as incorporators of a corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

### **ARTICLE I**

NAME OF THE CORPORATION. The name of the Corporation is: Readme, Inc.

### **ARTICLE II**

DURATION OF THE CORPORATION. The Corporation shall have perpetual existence.

### **ARTICLE III**

PURPOSE OF THE CORPORATION. The purpose of the Corporation is to carry out all activities permitted by the laws of the United States, and this state, and the applicable laws of the localities and jurisdictions in which the Corporation conducts business.

### **ARTICLE IV**

AUTHORIZED STOCK. The directors of the Corporation are authorized to issue ten thousand (10,000) shares of common stock, no par value.

### **ARTICLE V**

START OF BUSINESS. The Corporation will not commence business until at least five hundred (\$500.00) dollars have been received by it as consideration for the issuance of shares.
