ARTICLES OF INCORPORATION

OF

UNIVERSAL SYSTEM SERVICES, INC.

I, the undersigned, hereby execute the following for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be UNIVERSAL SYSTEM SERVICES, INC., and the principal place of business shall be 5831 N.W. 45th Drive, Gainesville, Alachua County, Florida 32653.

ARTICLE II - DURATION OF EXISTENCE
