ARTICLES OF INCORPORATION OF

Don's Telephone Services, Inc.

ARTICLE I - Name

The name of the corporation is: Don's Telephone Services, Inc.

ARTICLE II - Existence

This corporation shall commence existence on January 1, 1997.

ARTICLE III - Purpose

The general purpose for which this corporation is organized shall be the transacting of any or all lawful business for which corporations may be incorporated under the provisions of Chapter 607, Florida Statutes.

ARTICLE X - Indemnification

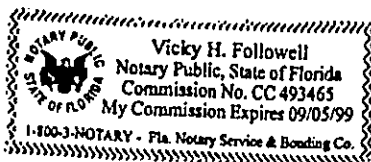
