**ARTICLES OF AMENDMENT OF**

LOVELACE, being the Vice President and Assistant Secretary, of QUANTUM CONTRACTING, INC., does hereby certify that the following Amendment to the Articles of Incorporation of QUANTUM CONTRACTING, INC. was approved by the Stockholders of said Corporation on the 1st day of June, 1999, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of QUANTUM CONTRACTING, INC. are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

**ARTICLE I**

4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.

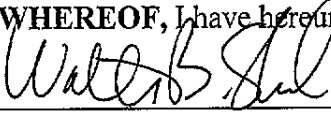
