The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a professional service corporation under Chapters 621 and 607 of the laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be:

**IRVING S. MARCUS, C.P.A., P.A.**

**ARTICLE II**

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

**ARTICLE III**

The corporation may render professional services practicing public accounting pursuant to Chapter 473, Florida Statutes, through its members, officers, employees and agents who are duly licensed or otherwise legally authorized to do so and may engage in any and all businesses and activities permitted by the laws of the State of Florida. And in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida General Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto, so far as such powers and privileges are consistent with, and not prohibited by, the Professional Service Corporation Act.

**ARTICLE IV**

The maximum number of shares which the corporation shall have authority to issue shall be 10,000 shares of common stock with a par value of \$1.00 per share.

**ARTICLE V**

The initial registered agent and street address of the initial registered office of the corporation shall be:
