**ARTICLE I**

The name of this corporation shall be ABS ENTERPRISES, INC.

**ARTICLE II**

This corporation shall have a perpetual existence, unless sooner dissolved according to law.

**ARTICLE V**



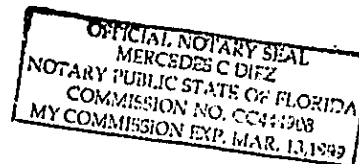
