In compliance with the requirements of F.S. Chapter 607, the undersigned, being a neutral person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### ARTICLE I

The name of the corporation is Energy Saving Associates, Inc. and the street address of the principal office of the Corporation is 2300 West Sample Road, Suite 304, Pompano Beach, Florida 33073.

#### **ARTICLE II**

The period of duration of the corporation is perpetual.

# ARTICLE III

The corporation is organized to engage in any activity or business permitted under the laws of the United States and the state of Florida.

#### ARTICLE IV

The corporation shall have the authority to issue a maximum of one thousand (1,000) shares, all of which shall be common shares of Capital Stock, with a par value of \$1.00 per share.
