Pursuant to Section 607.0202, Florida Statutes, these articles of Incorporation provide that:

1. The name of the corporation is Amerimaid, Inc. (the Corporation).

3. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of Common Stock, par value \$50.00 per share.
