# ARTICLES OF INCORPORATION

<u>of</u>

YA DETECTIVE AGENCY AND SECURITY PATROL, INC.

The undersigned subscriber, a natural person competent to contract, hereby associate and together to form a corporation under the Laws of the 1/ (0) State of Florida, Chapter 607, and subject to the following provisions:

### ARTICLE I - NAME.

The name of the corporation shall be:

VA DETECTIVE AGENCY AND SECURITY PATROL, INC.

### ARTICLE II - DURATION .

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation, or the date of execution and acknowledgement of these Articles.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited to:

- a. Any and all lawful business.
- b. Pursue its purposes and business in any and all locations foreign and  $\ensuremath{\mathsf{domestic}}$  .
- c. Acquire, own, hold, develop, deal in and with, maintain and operate, unlimitedly, such real and personal property of every kind and description within and without the State of Florida.
  - d. Buy and sell real and personal property of any nature whatsoever.

- i. Pay cash or issue capital stock, debentures, bonds, mortgages, or other obligations of the corporation for any acquisition by the corporation and for any other lawful purpose.
- j. Engage in the acquisition, ownership, sale, distribution and licensing of patents, improvements and franchises, trademarks and trade names, and to operate thereunder.
- k. Enter into, make and perform contracts of every kind and description with any persol, firm or association, corporation and body politic conducive to the attainment of any of the objects or purposes of the corporation.
- 1. Enter into any and all types of agreements relating to financing, factoring and guarantees and to guarantee or secure, in any way, the debts or obligations of any other persons, firms and/or corporations.
