ARTICLES OF INCORPORATION

0F

The undersigned subscriber, a natural person competent to contract, hereby associate and together to form a corporation under the Laws of the 12-10 State of Florida, Chapter 607, and subject to the following provisions:

ARTICLE I - NAME.

The name of the corporation shall be:
