The Articles of Incorporation were adopted and approved by the board of directors on December 4, 1996.

NAME OF CORPORATION

#### ARTICLES X - AMENDMENTS

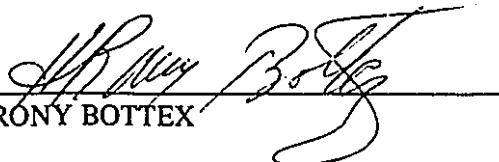

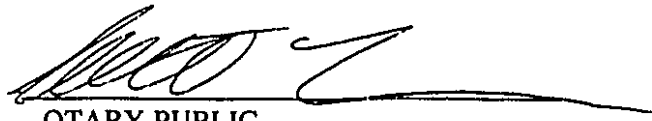
