We are in receipt of your Second Notice on the filing of the 2000 Uniform Business Report.

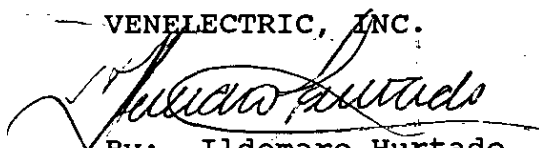
