This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation name hereinafter mentioned and to that end, does, by these Articles of Incorporation, set forth the following:

ARTICLE I

The name of the corporation is SUB-AQUATIC ADVENTURES, INC.

ARTICLE II

The address of the initial registered offices of the corporation shall be 727 Catherine Street, Key West, Fl. 33040 and the name of the initial registered agent for the corporation shall be Jodi Beth Schaefer, a resident of the State of Florida.

ARTICLE III


The initial Board of Directors of the Corporation shall consist of one (1) person, and the name and address of the person who is to serve as the sole director of the Corporation is as follows:


