**ARTICLE I - NAME**

The name of this Corporation is Victory Cab Co. initial address: 7916 Barrowood Street, Orlando, Florida 32824.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on December 2, 1996.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

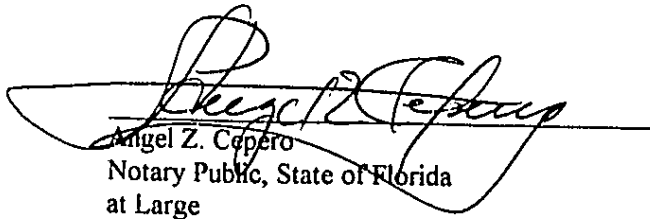

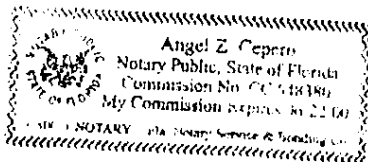
