ARTICLE I.

CORPORATE NAME

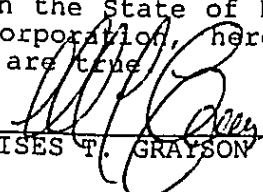

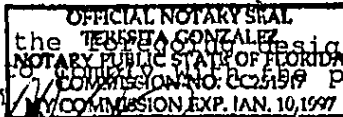
