ARTICLE I

NAME

The name of the corporation is LESTER CROCKETT ENTERPRISES, INC.

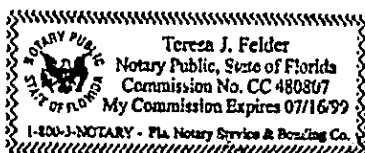
